#### **Environmental focus in all processes**

regulations, and must receive satisfactory training in the system and routines at the customer's place of work.

#### HSE objectives and prioritization

The overall objective for health, environment and safety at the company is:

- Our HSE routines and procedures must ensure that both employees and management work together towards our long-term goal, which is to avoid injuries and losses completely. The HSE goal is zero incidents.
- Through active measures, our projects must be carried out without personal injury, no pollution of the external environment and no material damage
- Our HSE procedures and routines must ensure that there is at all times a safe, positive and challenging working environment which safeguards the health and safety of all
- Sick leave must be lower than the average for our industry
- All unwanted incidents must be reported
